Revere Copper Products, Inc.

IndependenceGray / TCS II Satin™ or FreedomGray™ Warranty New Zealand

Revere Copper Products Inc. warrants to the original purchaser that it's IndependenceGray / TCS II Satin™ or FreedomGray™ products will be free from manufacturing defects, and will not perforate due to pitting corrosion for a period of twenty five (25) years. This warranty shall commence on the date of Revere Copper Products Inc. initial shipment of the product. Therefore the date on the delivery of initial supply of the product from Revere Copper Products Inc. to it's customer is the recognized start date of this warranty.

This IndependenceGray / TCS II Satin™ or FreedomGray™ product warranty does not apply to aesthetic staining or surface deterioration caused by exposure to surface contaminants or by failure to adhere to any of the clauses included in this warranty.

THIS WARRANTY DOES NOT APPLY IN THE EVENT THAT:

- 1) IndependenceGray / TCS II Satin™ or FreedomGray™ products were utilized in a manner inconsistent with standard accepted design detailing and construction practices for Copper as prescribed in the New Zealand Building Code, Section E2 / AS1 / 8.4 relating to Profiled Metal Roofing and Cladding. Any deviation from these accepted standard practices must first be cleared with Revere Copper Products Inc. or its authorized official distributor in New Zealand. Failure to observe this practice will void the manufacturer's warranty.
- 2) IndependenceGray / TCS II Satin™ or FreedomGray™ products were applied DIRECTLY over any decking material or underlay materials that have been chemically treated with material intended to retard fire in such materials, or ACQ (Alkaline Copper Quaternary) or CCA (Chromated Copper Arsenate) treated lumber. In all cases separation between the IndependenceGray / TCS II Satin™ products and the treated substrate must be achieved using an approved "Building Paper" product that creates a barrier between the metal roofing and the treated substrate without absorbing moisture.
- 3) The IndependenceGray / TCS II Satin™ or FreedomGray™ products involved in the warranty claim were not originally purchased directly from Revere Copper Products Inc. or from a Revere Copper Products Inc. authorized official distributor, dealer, or authorized representative.
- 4) IndependenceGray / TCS II Satin™ or FreedomGray™ products were utilized for other than its intended purpose, that being sheet metal roofing, cladding and flashing. Storage and protection of these products must be in accordance with the manufacturers published recommendations.
- 5) IndependenceGray / TCS II Satin™ or FreedomGray™ products are not properly installed or maintained in accordance with the written installation or maintenance standards published by Revere Copper Products Inc. or its authorized official distributor in effect at the time the material was originally utilized. In marine environments, IndependenceGray / TCS II Satin™ or FreedomGray™ products are required to be rinsed with fresh water at least quarterly. Most areas regularly washed by rainfall do not require manual watering unless extended drought conditions prevail. Areas unwashed by regular rainfall (eg. undersides of architectural features) should be manually rinsed with fresh water at least quarterly.

PLEASE NOTE THE FOLLOWING:

This product warranty applies only to IndependenceGray / TCS II Satin™ or FreedomGray™ products which remain in place at the site of the original construction and is extended solely to the original purchaser and the original owner of the building to which the IndependenceGray / TCS II Satin™ or FreedomGray™ products were applied with only the following two provisions allowing transfer of this warranty:

- 1.) This warranty may be transferred by the original owner of the building to which the Independence Gray/
 TCSII Satin™ and Freedom Gray™ products were applied due to the change of ownership of the building
 ONLY ONCE during the 25 year warranty period. This single transfer of this warranty will only apply to the
 first change of ownership made by the original owner to the first subsequent owner.
- 2.) If there is more than one change of ownership of the building to which the Independence Gray/ TCSII Satin™ and Freedom Gray™ products were applied during the first 15 years of the warranty period, then this warranty will automatically revert to a maximum 15 year non perforation warranty subject to all of the conditions described in this document.

This IndependenceGray / TCS II Satin™ or FreedomGray™ product warranty does not apply to mechanical, chemical or other damage sustained during shipment, storage, forming fabrication during or after erection, including without limitation damage caused by falling objects, acts of God, riots, explosions or other external forces

This IndependenceGray / TCS II Satin™ or FreedomGray™ product warranty does not apply to damage caused by corrosive fumes or condensates that are generated or released in or around the roof. This IndependenceGray / TCS II Satin™ or FreedomGray™ product warranty does not apply to damage caused by improper drainage or holding of water due to roof or sidewall pitch design.

In the event of the failure of any IndependenceGray / TCS II Satin™ or FreedomGray™ products to conform to the foregoing warranty, Revere Copper Products Inc. must be notified in writing within thirty (30) days of discovery of such failure and given adequate identification of the date of application of the IndependenceGray / TCS II Satin™ or FreedomGray™ products involved, together with invoice number and date of shipment. Failure to provide Revere Copper Products Inc. with such notice and documentation shall void the warranty.

The purchaser or owner's sole and exclusive remedy against Revere Copper Products Inc. and its authorized official distributor, and Revere Copper Products Inc. and it's authorized official distributor's sole obligation for any and all claims, whether for breach of contract, warranty, tort (including negligence) or otherwise, shall be limited to furnishing new product in place of the old product, less current scrap value, on a F.O.B. Revere Copper Products Inc. Rome, New York, USA basis.

Revere Copper Products Inc. and its authorized official distributor shall not in any event be liable for the labor cost to replace defective product nor for faulty application of IndependenceGray / TCS II Satin™ or FreedomGray™ products by third parties in either the original or any replacement application. Revere Copper Products Inc. and its authorized official distributor shall not be liable for any special, indirect or consequential damages arising from any claims arising hereunder.

THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OF IMPLIED, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
